

#### **PRIVACY NOTICE**

**MARCO MARKETING CONSULTANTS CORP**, (hereinafter "Marco Mkt") is a company aware of the responsibility and trust you place in us. We provide Point-of-Sale Execution Services, including marketing, promotions, logistics, POP placement, audits, BTL 360, design and production of materials, real-time reporting, business intelligence, technology applied to the point of sale, material logistics, inventory management, and personnel administration.

For this reason, we are committed to the proper handling of your Personal Data in compliance with the Federal Law on the Protection of Personal Data Held by Private Parties.

In the United States, data protection is not governed by a single federal law but rather a combination of federal and state laws addressing specific aspects of privacy and data security. Key federal laws include: (i)HIPAA (Health Insurance Portability and Accountability Act) – governing health information.,(ii) COPPA (Children's Online Privacy Protection Act) – regulating data protection for children under 13., (iii) GLBA (Gramm-Leach-Bliley Act) – applying to financial institutions.,(iv)FERPA (Family Educational Rights and Privacy Act) – protecting student educational records., and (v) FCRA (Fair Credit Reporting Act) – regulating consumer credit information.

### V. DATA SHARING AND TRANSFER

Your personal data may be shared with third parties within or outside the country, including individuals, companies, organizations, or authorities, for the purpose of fulfilling the services requested.

According to the Federal Law on the Protection of Personal Data Held by Private Parties, we ensure the proper handling of your Personal Data in compliance with its provisions.

## VI. CONSENT FOR PERSONAL DATA USE

Your data will be processed with your express or tacit consent. You have five (5) business days from the date this notice is made available to you to express your refusal for your data to be processed. If no objection is made, consent is assumed.

Consent is not required when:

- The processing is legally required.
- The data is publicly available.
- The data is anonymized.
- The data is necessary for compliance with legal obligations.



- There is an emergency situation that could potentially harm an individual, either personally or in their property.
- The data is essential for medical care, prevention, diagnosis, the provision of healthcare assistance, medical treatments, or the management of healthcare services, while the Data Subject is unable to provide consent, in accordance with the provisions of the General Health Law and other applicable legal regulations, and such data processing is carried out by a person subject to professional secrecy or an equivalent obligation.
- A resolution is issued by a competent authority.

### VII. PROTECTION AND TRANSFER PROCEDURE

The Data Subjects whose Personal Data is held by MARCO Mkt may, at any time, exercise their rights under the protection and transfer procedure.

The Data Subject must submit a request that meets the following requirements:

- a. The name and address or email of the Data Subject to communicate the response to their request;
- b. Documents proving the identity of the Data Subject or, where applicable, the legal representation of the person acting on their behalf;
- c. A clear and precise description of the Personal Data for which the Data Subject seeks to exercise any process;
- d. Any other element or document that facilitates the location of the Data Subject's Personal Data;
- e. A clear specification of the request and the legal grounds on which it is based;
- f. The reason for the request; an
- g. The modification(s) requested, in case the request concerns a specific use of their Personal Data.

This request must be submitted to MARCO Mkt through any of the following means:

- 1. By email.
- 2. By postal mail.
- 3. In person at MARCO Mkt's offices.
- 4. Through the website www.marcomkt.com.

The procedure that MARCO Mkt will adopt upon receiving the request is detailed in the Personal Data Protection Policy, which states that the Personal Data Protection Committee will inform the Data Subject, within a maximum period of 20 (twenty) calendar days from the date the request is received, of the determination made. If the request



is deemed valid, it will be implemented within 15 (fifteen) calendar days following the date the determination is communicated.

It is hereby informed that MARCO Mkt may extend the aforementioned timeframes if the particular circumstances of the case so require. The Data Subject will be notified of any such extension via the same means through which the request was submitted.
